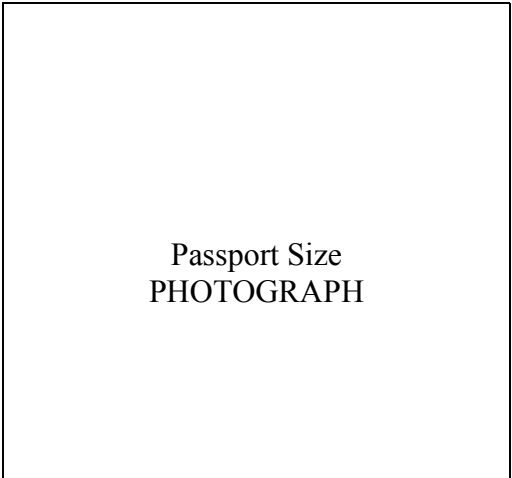

**IMPORTANT INFORMATION:**
