Subject: Implementation of Direct Benefit Transfer (DBT) for Apprentices undergoing training in PSU and States & Central Govt. Department under National Apprenticeship Training Scheme (NATS): Regarding

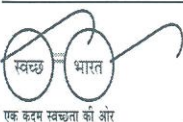
Dear Sir/Madam,

Reference is invited to this office letter No.BT/AA/12317 dated 29.01.2024 wherein postponement of implementation of DBT was conveyed. Now it has been decided by the Ministry that the Govt. Departments and PSUs in the Northern Region of the country registered with BOAT (NR) under NATS are required to implement the DBT for payment of stipend to the registered apprentices for the month of February, 2024 payable in the month of March, 2024 as the same has successfully been implemented in Southern Region of the Country. All such establishments are hereby informed to ensure DBT implementation as per the following guidelines:

1. For all registered Graduate & Technician apprentices for whom the stipend for the month of February, 2024 are payable in the month of March, 2024, it must be ensured that the stipend for the month of February, 2024 for all registered apprentices are paid on or before 5th of the following month by the establishment excluding Central Govt. share of stipend. Their RoP must be entered into NATS 2.0 portal (if registered in NATS 2.0 portal) immediately after making payment i.e. on or before 5th of the following month.
2. For the apprentices registered in NATS 1.0 portal, the information along with the Loss of Pay etc. must be provided to BOAT(NR) in the Excel template (copy enclosed) and after making payment of establishment share, the same must be sent to BOAT (NR) through mail id dbt@boatnr.org on or before 05th of the following month with a request for payment through DBT. On receipt of the same, BOAT (NR) will take necessary action to ensure that their payment through DBT is made at the earliest possible on receipt of the said confirmation mail from the establishments subject to display of their successful DBT registration on portal.
3. All such establishments must ensure that their apprentices have successfully completed DBT registration display on NATS 2.0 portal. For those apprentices having warning messages apprentices must be informed to take necessary action at their end as per warning message and complete their successful DBT registration process at the earliest.
