- Whether person can avail benefits under both the scheme i.e., NAPS and NATS;
- Beneficiaries can avail the benefits under NATS and NAPS based on their educational qualification.
- Beneficiaries under NATS are freshly pass-outs of Degree/Diploma in Engineering and Graduates of General stream.

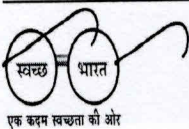
